AMENDMENT TO DECLARATION AND ESTABLISHMENT OF CONDITIONS, COVENANTS, RESERVATIONS AND RESTRICTIONS FOR ASPEN MEADOWS

Evergreen Properties, a California general partnership ("Evergreen"), executed a declaration ("Declaration") establishing a 25 lot subdivision named "Aspen Meadows" situated at Sunriver, a master planned community within the County of Deschutes, State

Said Declaration which provided for certain conditions, covenants, reservations and restrictions for Aspen Meadows was recorded in the records of Deschutes County on 15th day of September, 1989, in Book 192, Page 610 et. seq.

Evergreen desires to amend the Declaration by deleting the language now set forth in Article II, Section 2-F thereof relating to height restrictions and replacing it with substitute language.

Evergreen hereby declares as follows:

Article II, Section 2-F of the Declaration is hereby deleted and the following language in replacement thereof is added to the Declaration:

BUILDING HEIGHT. Building height maximums, measured to the top of the ridgeline from the finish grade shall be as follows:

> Lots 1 through 4: 21 feet Lots 5, 14 through 17: 23 feet, 6 inches Lots 6 through 13, 18 through 25: 25 feet

Lot owners must present verification that the building height is in compliance with Deschutes County Solar Ordinance and Sunriver Design Committee Manual; no structure, pole, tree or vegetation shall be placed or allowed to grow on any lot which at any time exceeds a height which violates the restriction of Deschutes County Solar Ordinance #83-037, as may be amended or replaced, limiting the height of solar fences to preclude blocking solar access on neighboring lots.
