THIRD AMENDMENT TO DECLARATION

FOR RENAISSANCE RIDGE

(FORMERLY KNOWN AS ASPEN RIM)

The Declaration of Protective Covenants, Conditions, Restrictions and Easements for Aspen Rim was recorded in the Deschutes County records on September 16, 2005, as Instrument No. 2005-62428 (the "Declaration"). By subsequent instruments, the name of Aspen Rim was changed to Renaissance Ridge. The Plat for Phase 1 of Aspen Rim was recorded in the Deschutes County records on December 16, 2005, as Instrument No. 2005-62426 (the "Aspen Rim Plat"). The owners have voted to amend the Declaration as provided below.

Section 3.1(c) of the Declaration is hereby amended by adding the following language to such section:

Limited Common Areas shall also include the twenty-two (22) foot Private Access Easement Areas designated on the Aspen Rim Plat abutting the following lots: 3-13, 23-32, 38-50, 51-62, 80-94, 111-112, and 143-153.

Except as necessary to give full effect to the foregoing amendment, the Declaration shall remain unmodified and in full force and effect.

IN WITNESS WHEREOF, the President and Secretary of the Renaissance Ridge Homeowners Association hereby certify that the foregoing Amendment was approved by not less than seventy-five percent (75%) of the voting rights in the Association as required by the Declaration and applicable law.
