Black, husband and wife, grantee, does hereby grant, bargain, sell and convey to said grantee, their heirs and assigns, all the following real property, with the tenements, hereditaments and appurtenances situated in the County of Deschutes, and State of Oregon, bounded and described as follows, to-wit:

Lot Six (6), Bend Golf Club Addition, according to the official plat thereof, on file in the office of the County Clerk for Deschutes County and State of Oregon.

Together with such water rights as are granted by that certain Agreement between T. E. Roats and Barbara Roats, husband and wife as first parties and the grantors herein as second parties. Said agreement is recorded in Mortgages records, Deschutes County, Oregon, dated February 14, 1964, Book 103, Page 445.

It is subject, however, to the restriction that these premises shall be used for residential purposes only, and subject further to the restriction that no building, fence or other improvement of any kind or nature shall be constructed thereon without the first prior approval being had and obtained from the Board of Directors of the Grantors herein.

To Have and to Hold the above described and granted premises unto the said grantee, their heirs and assigns forever.

And the grantor does covenant that it is lawfully seized in fee simple of the above granted premises free from all incumbrances,

and that it will and its successors shall warrant and forever defend the above granted premises, and every part and parcel thereof, against the lawful claims and demands of all persons whomsoever.
