Lot One (1), Bend Golf Club Addition, according to the official plat thereof on file in the office of the County Clerk for Deschutes County and State of Oregon.

Together with such water rights as are granted by that certain Agreement between W.E. Roats and Barbara Roats, husband and wife as first parties and the grantors herein as second parties.
