1 CORRECTION OF TYPOGRAPHICAL ERROR TO 1989 REVISED BY-LAWS2 SYLVAN KNOLLS - BOONES BOROUGH PROPERTY OWNERS' ASSOCIATION, INC.

3 This revision of the By-Laws were approved at the annual meeting of the  
 4 Property Owners on June 14, 1989, by a vote of at least 80% of the eligible  
 5 voting members of the Sylvan Knolls - Boones Borough Property Owners' Association  
 6 represented at that meeting. Due to a typographical error on the final draft  
 7 they were recorded incorrectly in Vol. 186 Pages 2913 thru 2928, on July 26,  
 8 1989 with the Deschutes County Clerk.

9 The changes and/or corrections are as follows and the page numbers stated  
 10 are to be found on the bottom left-hand side of the copy given to each Property  
 11 Owner:

12 SECTION 1, ARTICLE III, ORGANIZATION AND PROCEDURES, PAGE 2, LINE 11.

13 Delete as originally written and recorded in Vol. 186, Page 2914, with Deschutes  
 14 County, and substitute in its place the following correction:

15 staggered terms. In the election taking place in 1989, two (2)

16 SECTION 1, ARTICLE VII, AMENDMENTS, PAGE 9, Delete entirely as originally  
 17 written and recorded in Vol. 186, Page 2921, with Deschutes County, and sub-  
 18 stitute in its place the following correction:

19 These By-Laws of the Association and Restrictions may be amended, repealed,  
 20 or altered in the whole or in part by a two-third (2/3) majority vote of the  
 21 eligible voters represented at the meeting.

 25 the same two original sections previously filed, of record in Deschutes County,

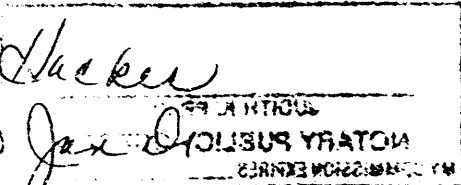
