All property owners, owning property in the Boulder Ridge Subdivision, agree to the following amendments of the Declaration of Covenants, Conditions, and Restrictions for Boulder Ridge, Inc.

AMENDMENTS:

Paragraph 1-b, Page 1 is amended as follows:

No building shall be erected which shall exceed twenty four (24) feet in height to the top 1. of the roof ridge for a single level home and thirty (30) feet in height to the top of the roof ridge for a two story home. Height shall be measured from natural grade. Natural grade means the average of the natural ground elevations prior to construction of all walls of the building. Natural grade shall be shown on all building plans submitted to the Architectural Review Committee.

Paragraph 2-d, Page 2 is amended as follows:

The following lots shall be restricted to single level homes with a roof ridge height not to 2. exceed twenty four (24) feet in height from natural grade: 1-12, and 36-46. All other lots in the Boulder Ridge Development can be occupied by either a single level or two story home.

Paragraph 8-a, Page 3 is amended as follows:

No residence shall be constructed with less than 1600 square feet of living area, exclusive 3. of garages, porches and out buildings. Detached garages shall be constructed of quality materials and have an appearance which will conform to the residence.
