The purpose of this instrument is to amend those certain Protective Covenants and Conditions (hereinafter referred to as Declarations) for Buck Run Third Addition, Deschutes County, Oregon, which consist of five pages and were recorded August 18, 1998 at Volume 508, pages 88-92 of Deschutes County Deed Records.

This Amendment is made pursuant to Article III, Section 3 of Declaration, which authorizes amendment "by owners of at least 75% of the property in Buck Run Third Addition."

The Declaration is hereby amended as follows:

Article IV General Provisions: Exceptions. Lots 61, 62, 63 and 64 Third Addition Buck Run are now being developed as single-family residential lots and exclusions stated in Article IV General Provisions: Exceptions no longer apply and these lots shall be subject to all the CC&Rs of Buck Run Third Addition.
