AMENDMENT #2 TO THE

COVENANTS, CONDITIONS, AND RESTRICTIONS

FOR CANAL VIEW

Section 5.13 of the Canal View C, C & R's (recorded as document number 96-37880 in Deschutes County Records) is hereby amended. The minimum size for a residence in Canal View shall be 1,600 square feet (garages and covered porches are not included in the calculation of square footage). Homes under construction on Lots 12 and 29 shall be allowed in accordance with the original 1400 square foot minimum.

Section 4.3.E is also hereby amended. The following sentence shall be added at the end of this Section: "All required lawn areas shall be planted with sod. Required lawn areas shall not be planted with seed".

In accordance with Section 9.2 the undersigned, as current owners of more than two-thirds of the lots in Canal View, approve of this amendment.

This Amendment applies to all property within the Canal View subdivision, more particularly described as:

The North half of the Northeast Quarter of the Southwest Quarter (N 1/2 NE 1/4 SW 1/4) of Section Fifteen (15), Township Seventeen (17) South, Range Twelve(12), East of the Willamette Meridian, Deschutes County, Oregon.

EXCEPTING that portion lying withoin the boundariew of Country View Estates, a platted subdivision.

ALSO EXCEPTION THEREFROM:

Beginning at the SW 1/16 corner of the centerline of said Section 15; thence along the centerline of said Section North 89 38' 20" East, 1132.98 feet to the true point of beginning of this description; thence leaving said centerline South 69 25'50"West, 232.61 feet; thence South 39 00' 45" West, 170.00 feet; thence North 24 15'59"West, 231.64 feet to a point on the said centerline; thence along the said centerline North 89 38'20"East, 420.00 feet to the true point of beginning and the terminus of this description.
