KNOW ALL MEN BY THESE PRESENTS, That the undersigned, being a majority of the owners of the lots in the subdivision at CHRISTIE ACRES, as shown by the plat thereof on file in the office of the County Clerk of Deschutes County, Oregon, do hereby amend the Building and Use Restrictions recorded March 19, 1980, in Volume 318, Page 539, Deschutes County Deed Records, as follows:

#23. No residence shall be constructed on Lots 1, 3, 4, 5, Block 1, Lots 1, 2, 3, 4, Block 2 consisting of less than 1400 square feet living area, exclusive of garages, porches, decks and outbuildings. On Lots 1, 2, 3, Block 3 no residence shall be constructed consisting of less than 1800 square feet, exclusive of garages, porches, decks and outbuildings.

EXCEPT as hereinabove amended, the Building and Use Restrictions as recorded shall remain in full force and effect.
