

NOTICE OF LOCATION

PACIFIC GAS TRANSMISSION COMPANY, a California corporation, pursuant to the rights conveyed to it by that certain grant of easements dated December 17, 1959 and recorded January 4, 1960 in Volume 123 of the Official Records of the County of Deschutes State of Oregon, at page 508, does hereby further define the location of the strip of the lands described in said grant as follows:

A strip of land 100 feet wide over and across a portion of the East Half of the Southeast Quarter of Section 18, Township 17 South, Range 13, East of the Willamette Meridian, and lying 30 feet Westerly and 70 feet Easterly of and at right angles to the following described center-line:

Commencing at the East Quarter corner of Section 18, Township 17 South, Range 13, East of the Willamette Meridian; thence West 412 feet to the true point of beginning of this description; thence South 26° 53' West 694 feet; thence South 19° 23' West 309 feet, more or less, to a point on the Southwesterly line of the property. Said Center-line is further defined in PGT Drawing O-De-13, Revision 0, dated September 13, 1961, which is incorporated herein by reference.

Nothing herein contained shall, or shall be construed to, modify in any way or terminate any of the rights and obligations of the parties under and by virtue of the said grant of easements in the lands therein described or the said strip thereof.

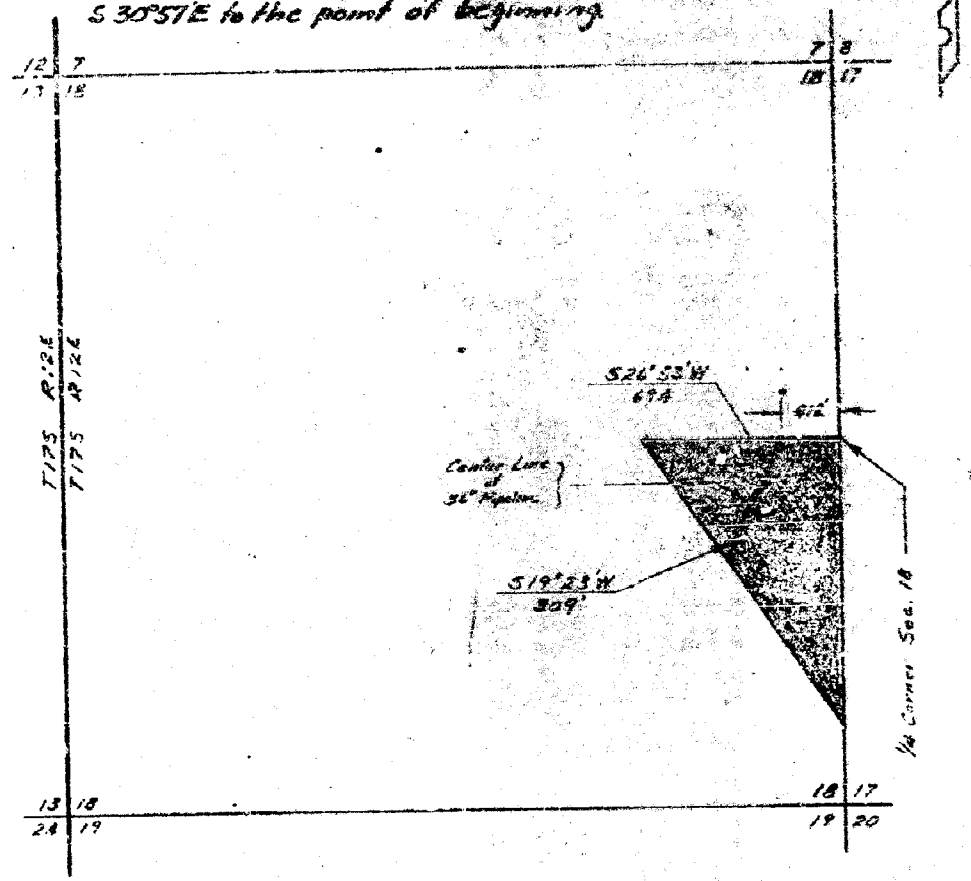
