

NOTICE OF LOCATION

PACIFIC GAS TRANSMISSION COMPANY, a California corporation, pursuant to the rights conveyed to it by that certain grant of easements dated December 17, 1959 and recorded January 4, 1960 in Volume 123 of the Official Records of the County of Deschutes, State of Oregon, at page 510, does hereby further define the location of the strip of the lands described in said grant as follows:

A strip of land 100 feet wide over and across a portion of the Southeast Quarter of Section 18, Township 17 South, Range 13, East of the Willamette Meridian, and lying 30 feet Westerly and 70 feet Easterly of and at right angles to the following described centerline:

Commencing at the Southeast corner of Section 18, Township 17 South, Range 13, East of the Willamette Meridian; thence West 1,456 feet to the true point of beginning of this description; thence North 19° 23' East 1,846 feet, more or less, to a point on the Northeasterly line of the property. Said centerline is further defined in PGT Drawing O-De-14, Revision 0, dated September 13, 1961, which is incorporated herein by reference.

Nothing herein contained shall, or shall be construed to, modify in any way or terminate any of the rights and obligations of the parties under and by virtue of the said grant of easements in the lands therein described or the said strip thereof.

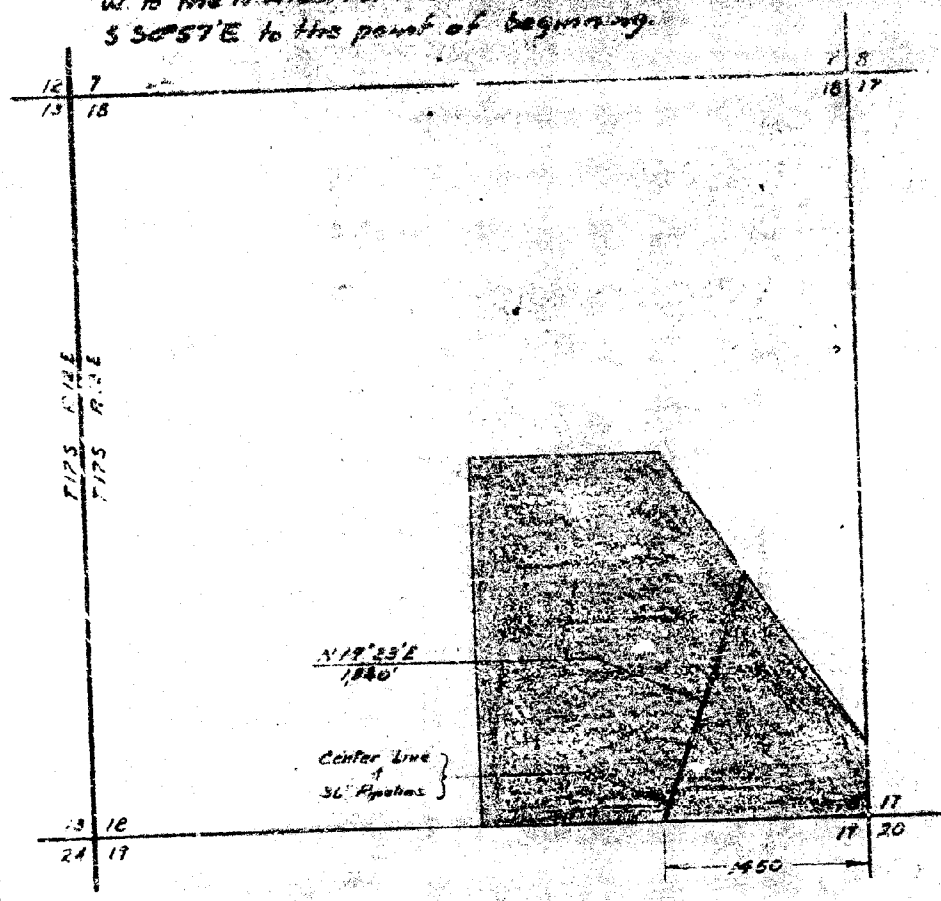
