BLAIR, being the sole owners of the Subdivision known as CLINE FALLS OASIS SUBDIVISION, Deschutes County, Oregon, in order to provide for the orderly development of said Subdivision, do hereby amend Section (4) of the building and use restrictions of file in the office of the County Clerk of Deschutes County, Oregon, dated NOVEMBER 14, 1967 and recorded November 16, 1967 in Book 156 page 14 Deed Records to provide that Section (4) reads as follows to wit:

- (4) No mobile home except double wide with not less than 1,000 square feet, wood siding, composition or shake roof and placed on continuous poured concrete or masonry block foundation shall be permitted.

EXCEPT as hereinabove amended, the Building and Use Restrictions as recorded shall remain in full force and effect.

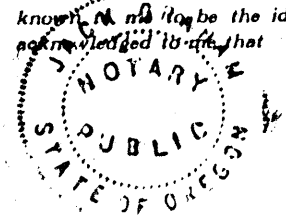
