## WARRANTY DEED

FRANKS, his wife, of Deschutes County, State of Oregon, in consideration of three thousand one hundred dollars (\$3,100) and other good and valuable consideration, paid by the United States of America, the receipt whereof is hereby acknowledged, have bargained and sold, and by these presents do grant, barg-in, sell and convey unto THE UNITED STATES OF AMERICA, and its assigns, a perpetual easement to flood, seep or otherwise damage by release of water into the Deschutes River from the Wickiup Reservoir as required for operation of the Deschutes Federal Reclamation Project, the following described real property situate in the County of Deschutes, State of Oregon, to wit:

> The southwest quarter of the northeast quarter (SWINE), the southeast quarter of the northwest quarter (SE4sW4) and the west half of the west half (Will) of section twenty-four (2h); the south half of the southeast quarter (SiSE) of section twenty-three (23); the northeast quarter of the northeast quarter (MRANEA), and the west half of the southeast quarter (W2SE2) of section twenty-six (26); the northeast quarter of the southeast quarter (NEISE) of section thirtyfour (34); the west half of the northwest quarter (WaNWa), the southeast quarter of the northwest quarter (SE/1964) and the northwest quarter of the southwest quarter (MiSW1) of section thirty-five (35), all in township twenty (20) south, range ten (10) east, Willamette meridian, containing six hundred forty (640) acres, more or less.

Subject to presently used rights of way for canals. ditches, flumes, pipelines, railroads, highways, roads, telephone, telegraph and power transmission lines, created in favor of the public or public utilities.
