

AMENDED BUILDING AND USE RESTRICTIONS
DESCHUTES RIVER RECREATION HOMESITES, INC.

KNOW ALL MEN BY THESE PRESENTS:

Pursuant to majority vote of the Board of Directors of the above named corporation, those certain building and use restrictions dated the 28th day of October, 1964, and recorded October 29, 1964, in Book 141 at pages 202-203, Deed Records, Deschutes County, Oregon, are hereby amended as follows:

1) The covenants, conditions and restrictions set forth in said building and use restrictions of October 28, 1964, shall additionally apply to Blocks 55 to 61, inclusive, of Unit Nine (9), Deschutes River Recreation Homesites, Inc., according to the official map and plat of said Unit 9 (Parts One (1) and Two (2)), on file in the office of the County Clerk, Deschutes County, Oregon.

2) ~~The following described Lots may be used for multiple residential purposes:~~

- Lots 24 through 47, Block 37;
- Lots 47 through 66, Block 16;
- Lots 1 through 24, Block 42;

3) The following described Lots may be used for residential or commercial purposes:

- Lots 47 through 51, Block 41;
- Lots 80 through 84, Block 33;

4) All other covenants, conditions and restrictions of said instrument of October 28, 1964, aforesaid, shall remain in full force and effect.
