

RESERVATION

THIS INDENTURE, Made this \_\_\_\_\_ day of June, 1965, by  
DESCHUTES RIVER RECREATION HOMESITES, INC., an Oregon corpor-  
ation, hereinafter designated "Company",

WITNESSETH:

WHEREAS, The Company is the owner of certain lands in Deschutes  
County, Oregon, platted as Deschutes River Recreation Homesites, Unit 6,  
Parts 1 and 2, as more particularly appears in the map and plat thereof on  
file in the office of the County Clerk of said County and State; and

WHEREAS, The Company desires to create certain permanent ease-  
ments and rights-of-way for the use and benefit of all the Lots contained in  
said platted area;

NOW, THEREFORE, For valuable consideration, the Company does  
hereby reserve the following described portions for the use and benefit of  
all Lots contained in said platted areas, as follows:

An easement and right-of-way thirty (30') feet in width across  
Lot numbered One (1), Block numbered Sixty-four (64) for in-  
gress and egress to and from Recreation Area No. 2, said  
easement to have a northerly terminus on the south line of  
Mountain Sheep Lane, and a southerly terminus on the west  
line of Recreation Area No. 2, and to be thirty (30') feet from  
and parallel to the easterly line of said Lot 1, running in a  
course north 51° 54' west, all in Deschutes River Recreation  
Homesites, Unit 6, Part 1.

An easement and right-of-way thirty (30') feet in width across  
Lot numbered Seventy (70), Block numbered Seventy (70) for in-  
gress and egress to and from Recreation Area No. 7, said  
easement to be thirty (30') feet from and parallel to the southerly  
line of said Lot 70, said southerly line running in a course north  
51° 35' west, all in Deschutes River Recreation Homesites, Unit 6,  
Part 2.

An easement and right-of-way across the east thirty (30') feet of  
Lot Seventy-five (75), Block Seventy-six (76) for ingress and egress  
to and from Recreation Area No. 9, all in Deschutes River Recrea-  
tion Homesites, Unit 6, Part 2.

That said reservations described herein shall include the right to con-  
struct, maintain and repair said accesses to said recreation areas, together  
with all necessary incidents relative thereto.

It is the intention of this instrument that these reservations contained herein shall be in perpetuity and run for the use and benefit of all lots in blocks contained in Deschutes River Recreation Homesites Unit 6, Parts 1 and 2, above referred to.

IN WITNESS WHEREOF, Company has caused these presents to be executed by its President and Secretary, pursuant to order of its Board of Directors, and has affixed the Seal of said Corporation hereto the day and year first above written.

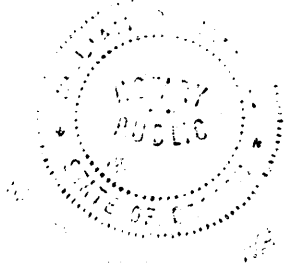
