PIRST AMERIDED DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS POR THE EAGLE CREST PLANNED COMMUNITY

THIS FIRST AMENDED DECLARATION, made this 7 tday of October, 1987, by EAGLE CREST PARTNERS LTD., an Oregon limited partnership, hereinafter referred to as "Declarant" and Eagle Crest Master Association, an Oregon non-profit corporation, hereinafter referred to as "Association," is as follows:

RECITALS

- A. On or about June 24, 1985, Declarant caused to be recorded that certain Declaration of Covenants, Conditions and Restrictions for the Eagle Crest Planned Community (the "Existing Declaration"), at Book 98, Page 675 of the Official Records of the County Recorder of Deschutes County, Oregon. The Existing Declaration provides for the creation of a master planned community located near Redmond, Oregon, all pursuant to the terms set forth in the Existing Declaration. the terms set forth in the Existing Declaration.
- B. Paragraph 12.1(a) of the Existing Declaration provides that the Existing Declaration may be amended from time to time by vote or written approval of a "Super-Majority of Owners" (as the quoted term is defined in the Existing Declaration). A Super-Majority of Owners, as of the date hereof, means the vote or written assent of Non-Majority of Owners entitled to vote or so assent and who collectively are shiftled to vote or so assent and who collectively are shiftled to vote or so assent and who collectively are shiftled to vote or so assent and who collectively are shiftled to vote or so assent and who collectively are shiftled to exercise more than 75% of votes which may be exercised by such Non-Declarant Owners and the consent of Declarant.

- NOW, THEREFORE, the Existing Declaration is hereby amended in the following respects;
- Paragraph 12.1(a) is hereby amended by deleting the phrase "Super-Majority
 of Owners" and substituting therefor the phrase "Majority of Owners."
- 2. Exhibit B attached hereto is hereby deleted in its entirety and a new Exhibit B in the form of Addendum A attached hereto and made a part hereof is hereby substituted therefor.
- Except as hereinabove set forth, the Existing Declaration shall continue in full force and effect without any change whatsoever.
- IN WITNESS WHEREOF, this Pirst Amended Declaration of Covenants, Conditions and Restrictions for the Eagle Crest Planned Community has been adopted as provided above, effective as of the date first-above written.
