d) <u>Exterior Walls</u>: shall be of natural wood or manufactured wood products as approved by the Committee. No T-111, metal, vinyl or plywood siding will be allowed. Stucco will be allowed as an accent only. It is the intention exterior colors shall be compatible with neighboring homes.

To:

Exterior Walls: shall be of natural wood or manufactured wood products as approved by the Committee. No T-111, 48*x96* panel or sheet siding vertically installed, metal, vinyl or plywood siding will be allowed. Stucco will be allowed as an accent only. It is the intention exterior colors shall be compatible with neighboring homes.
