DESCRIPTION SHEET

EASTSIDE BUSINESS AND INDUSTRIAL PARK, City of Bend, Deschutes County, Oregon.

Block 1: Lots 1, 2, 3, 5, 6, 7, 9 and Lots 1, 2, 3, 4 of the Replat of Lot 8.

EXCEPT a portion of Lot 2, Block 1, being more particularly described as follows: Beginning at the Southwest corner of Lot 2 in Block 1 as shown on the Plat of the EASTSIDE BUSINESS AND INDUSTRIAL PARK, on record with the Deschutes County Surveyor, Deschutes County, Oregon, thence due North 200.00 feet; thence South 64°49'05" East, 318.90 feet; thence along the arc of a 230 foot radius curve left 72.30 feet, the chord of which bears South 26°43'26" West, 72.00 feet; thence due West 256.22 feet to the point of beginning.
