

AMENDED BUILDING AND USE RESTRICTIONS

BE IT KNOWN That all of the undersigned owners of all property within Edge O' The Pines Addition to the City of Sisters, Deschutes County, Oregon, hereby amend those building and use restrictions recorded in Vol. 149, page 1 Deed Records, Deschutes County, Oregon, as follows:

1) Paragraph 1 shall be amended to provide:

All Mobile Homes 500 square feet or larger shall be permitted provided none may be under 10 feet wide.

2) Paragraph 4 shall be amended to permit painted wooden out-buildings, provided they are of substantial construction and compatible with the Mobile Homes and other buildings in the subdivision.
