

AMENDMENT TO DECLARATION SUBMITTING FAIRWAY ISLAND
HOUSES I TO OREGON UNIT OWNERSHIP LAW (AND SUPPLE-
MENT DECLARATION CHANGING THE NAME THERETO TO MEADOW
HOUSES AND ANNEXING MEADOW HOUSES TO MEADOW VILLAGE

ON July 11, 1969, a Declaration Submitting Fairway Island Houses I to Oregon Unit Ownership Law was recorded in Volume 165 of the Records of Deeds of Deschutes County, Oregon, at Page 496 (and on June 26, 1971 a Supplemental Declaration changing the name thereto to Meadow Houses was recorded in Volume 176 of the Records of Deeds of Deschutes County, Oregon, at Page 36).
