FIRST AMENDMENT TO DECLARATION OF PROTECTIVE COVENANTS, CONDITIONS, **RESTRICTIONS AND EASEMENTS** FOR FIELDSTONE CROSSING

THIS FIRST AMENDMENT TO DECLARATION OF PROTECTIVE COVENANTS, CONDITIONS, RESTRICTIONS AND EASEMENTS FOR FIELDSTONE CROSSING is made this First day of May 2005, by FIELDSTONE CROSSING OWNERS ASSOCIATION (the "Association").

RECITALS

- A. The Declaration of Protective Covenants, Conditions, Restrictions and Easements for Fieldstone Crossing was recorded October 6, 2004, in the records of Deschutes County, Oregon as Document 2004-60167 (the "Declaration"). Association is the association of owners established pursuant to the Declaration.
- B. In accordance with Section 14.2 of the Declaration, by affirmative vote or written consent of Owners holding not less than seventy-five percent (75%) of the Association, together with the written consent of the Class B member, the Owners wish to amend the Declaration.

AMENDMENTS

- 1. Article 6.11 is hereby amended to read as follows:
 - Signs. No signs shall be erected or maintained on any lot except that 6.11 not more than one "For Sale" sign placed by the Owner, Declarant or by a licensed real estate agent, not exceeding twenty-four (24) inches high and thirty-six (36) inches long, may be temporarily displayed on any lot, except that two such signs may be placed on a Lot during the course of initial construction of a dwelling on such Lot. "For Rent" or "For Lease" signs are prohibited. Signs placed in the window of the residence on the Lot are prohibited.
- 2. Article 6.30 is hereby added to the Declaration:

After recording, return to Amerititle 15 OREGON AVENUE, BEND 6.31 American Flags. Members wishing to display the American Flag on their Lot shall do so by hanging it from a pole designed for that purpose, attached to a garage wing or post only. Size shall be limited to those sizes most commonly seen for residential house display. American flags may not be displayed by adherence to fences or window. Members wishing to display the American Flag in another fashion must receive written approval from the Architectural Review Committee before installation.
