## By-Law Amendment

#### FRYREAR RANCH HOMEOWNERS ASSOCIATION

Move to amend Article VIII, Section 8.02: Structures

The words "Any construction issues will be brought to the Architectural Control Committee for resolution" are to be added. The amended bylaw will now read;

Amending 2003-57113 2003-80454

**Section 8.02 Structures** 

No building, fence, wall, radio or television antennae or transmitter, satellite dish or other structure shall be erected, placed, or altered on any tract or building site within the Property, or excavation or clearing therefore undertaken, until the plans, specifications, and plot plans thereof are submitted by the owner or the owner's representative to the Architectural Control Committee and approved by the committee. If such plans and specifications are disapproved of, (or, if conditionally approved, unless the conditions thereof be complied with) the project construction shall not be undertaken, or if undertaken, a violation thereof may be abated by legal proceedings by any party having an interest in the enforcement thereof irrespective of the time of completion thereof. The Architectural Control Committee shall in no way confirm or guarantee any assumed geological conditions, safety, or structural standards or construction methods. The Architectural Control Committee (ACC) shall, in good faith, exercise discretionary approval or disapproval on the basis of minimizing interference with the enjoyment of adjacent properties, protecting property values, and enforcing improvement uses and occupancy in a pleasing but not sterile or uniform combination. In the event the ACC fails to approve or disapprove such plans, etc., within thirty (30) days after said plans and specifications have been submitted to it, approval shall not be required, and this article shall be deemed to have been fully complied with.

Any construction issues will be brought to the ACC for resolution.


