This SUPPLEMENTARY DECLARATION is made as of the 1st day of April, 1993, by Broken Top Limited Partnership ("Declarant"), an Oregon Limited Partnership, as Declarant under the terms of a certain Declaration of Covenants, Conditions, and Restrictions for Broken Top Community Association (the "Declaration") dated October 27, 1992, and filed of record in Book 280 at Pages 1492 through 1545 in the Deed Records of Deschutes County, Oregon.

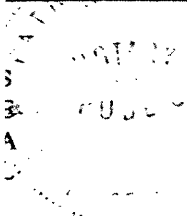
