Article VII, Section 1, is amended by adding Lot 42 to the list of lots which may use the private drive access and which shall be subject to all of the obligations of said Article VII.

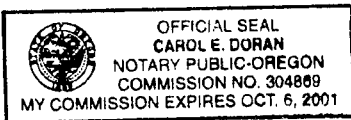


