

AMENDED
 PROTECTIVE COVENANTS FOR THE SUBDIVISION OF
 HEIERMAN - McCORMICK ADDITION
 CITY OF REDMOND
 DESCHUTES COUNTY, OREGON

KNOW ALL MEN BY THESE PRESENTS, That the undersigned, who are a majority of the owners of Heierman-McCormick Addition, do hereby declare that the said property and the whole thereof shall be subject to the following covenants, conditions and restrictions, which shall run with the land and be for the benefit thereof, to-wit:

SECTION 1. LAND USE AND BUILDING TYPE in the Protective Covenants for the subdivision of Heierman-McCormick Addition recorded on April 1, 1964, in Vol. 138, page 487, Deed Records, Deschutes County, Oregon, shall be amended to read as follows:

1. LAND USE AND BUILDING TYPE

All lots shall be used for one detached single family dwelling not to exceed one and one-half stories in height and a private garage for not more than two cars. The dwelling shall contain not less than 900 square feet of area. EXCEPT lots numbered 7, 8, 9, in Block 6, lots numbered 7, 8, 9, 10, 11, 12, in Block 7, and lot numbered 8 in Block 2 may be designated as multiple use. (Res. and Comm.)
