


AMENDMENT TO

DESCHUTES COUNTY, OREGON

1. Alterra Investments LLC, an Oregon limited liability company, recorded on October 30, 2006 as instrument #2006-72039 in the office of the County Clerk of Deschutes County, Oregon certain "Heritage Place Subdivision Declaration of Covenants, Conditions, and Restrictions."
2. The Heritage Place Subdivision Declaration of Covenants, Conditions, and Restrictions at paragraph 6.2 provides that Owners of 75% of the Lots may terminate, extend, modify, or amend any Covenant, Condition or Restriction in whole or in part.
3. The undersigned being 75% (6 of 8) of the current Owners of the Lots in Heritage Place Subdivision agree to the following:
  - a. Terminate from paragraph 4.7 "All Fences material shall be powder-coated, welded metal fencing with horizontal pickets - exceptions shall require ARC approval."
  - b. Terminate entire paragraph 4.20.
4. All other terms and condition of the Heritage Place Subdivision Declaration of Covenants, Conditions, and Restrictions shall remain the same.

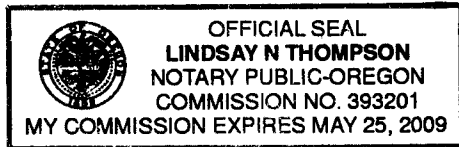

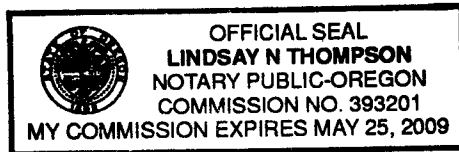
