## AMENDMENT TO **BUILDING AND USE RESTRICTIONS OF** HIDDEN VALLEY MOBILE ESTATES

This AMENDMENT to the building and use restrictions for Hidden Valley Estates, which were recorded on June 15, 1969 in Book 165 at page 571 of the Deed Records of Deschutes County, Oregon, as amended by addendum dated June 6, 1972 and recorded in Book 185 at page 429 of the . Deed Records of Deschutes County, Oregon is made by a majority of the owners of lots comprising Hidden Valley Mobile Estates in Deschutes County, Oregon to amend Sections 1, 2 and 3 of the Building and Use Restrictions to read as follows:

- The Hidden Valley Mobile Estate property shall be used for placement of 1. mobile homes and construction of singe family conventional homes.
- No mobile home smaller than twelve (12) feet wide by forty (40) feet long 2. shall be placed upon a lot and not more than one (1) mobile home shall be placed upon a lot. All mobile homes shall be in good condition and shall be kept painted an remain esthetically compatible with the other mobile homes in the tract. No conventional homes shall contain less than 900 square fee and shall be constructed in accordance with the building codes of the City of Redmond and/or Deschutes County.
- Mobile homes and conventional homes shall be set back form the streets a 3. minimum of forty (40) feet and shall not be placed nearer than seven (7) feet to any side lot line, except that Lot 1, Block 11; shall have a set back from the side streets of fifteen (15) feet, said side street being 37th Street on Lot 1, Block 2, and Lot 8, Block 1; and Nickernut Street being the side street of Lot 1 Block 11, and Lot 11, Block 2.

This Amendment shall become effective only upon recordation in the records of Deschutes County, Oregon.
