AMENDMENT FOR BYLAWS OF THE ASSOCIATION OF UNIT OWNERS OF KITTY HAWK CONDOMINIUMS

This amendment for THE ASSOCIATION OF UNIT OWNERS OF KITTY HAWK CONDOMINIUMS is made this 14th day of October , 1983 by the Board of Directors for the Association of Unit Owners of Kitty Hawk Condominiums. Policy change has been made as empowered under Bylaws Section 12.

Therefore, Bylaws for the Association of Unit Owners of Kitty Hawk Condominiums recorded in Volume 279, Page 371, Section 5, Paragraph 5.2 Number, Tenure and Qualifications, will state the following change:

The number of directors of the Association shall be no less than three nor more than five. If there is a tie vote at a Board meeting, then in only those instances the Chairman of the Board is authorized to cast an additional, and deciding vote.

Upon the initial election of directors, one to two shall be elected for a term of one year, one to two for two years and one for three years, with the term of directors subsequently elected to be for a period of three years.

A Director must be an owner as defined in Paragraph 1 of the Declarations. No owner may be elected to the Board of Directors if a lien, filed against the owner's property under the authority granted in Paragraph 21 of the Declarations, remains unpaid. A Director is automatically disqualified if, during his/her term of office, a lien is filed against the Director's property under the authority granted in Paragraph 21 of the Declarations.

Except for the above disqualification each director shall hold office until the annual meeting of the year in which his/her term shall expire and until the election and qualification of his/her successor.
