AMENDMENT FOR BYLAWS OF
THE ASSOCIATION OF UNIT OWNERS
OF MEADOW HOUSES WEST

This amendment for THE ASSOCIATION OF UNIT OWNERS OF MEADOW HOUSES WEST is made this 26th day of July, 1984, by the Board of Directors for the Association of Unit Owners of Meadow Houses West. Policy change has been made as empowered under Bylaws Article VIII.

Therefore, Bylaws for the Association of Unit Owners of Meadow Houses West recorded in Volume 187, Page 680, Article V, Paragraph 4. Default in Payment of Common Expenses, will state the following change:

In the event of default by any unit owner in paying to the Association the assessed common expenses, such unit owner shall be obligated to pay interest at the rate of prime plus 4% per annum on such common expenses from the due date thereof, together with all expenses, including attorneys' fees, incurred by the Association in any proceeding brought to collect such unpaid expenses, or any appeal therefrom. The board of directors shall have the right and duty to recover for the Association such common expenses, together with interest thereon, and expenses of the proceeding, including attorneys' fees, by an action brought against such unit owner or by foreclosure of the lien upon the unit granted by the Oregon Unit Ownership Law. The board of directors shall notify the holder of any mortgage upon such a unit of the default, if such holder has so requested in writing.

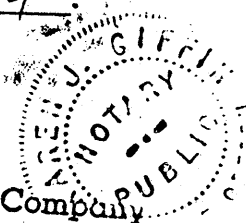
