4. Declaration of Assessments for Mill "A" Area of Shevlin Center dated August 14, 1986.

Grantor also subjects the above described lot to the following conditions:

- 1. Grantees shall have 5 years from September 1, 1986 to remodel the existing East structure and 7 years to do the same to the West structure on the above described lot and 3 years to hook-up to the City of Bend required water system for fire protection. Grantees shall give Grantor 30 days advance written notice prior to disconnecting from the old fire protection system.
- 2. Grantees shall be responsible for the operation, maintenance, upkeep and cost of the existing fire protection system until such time as they hook up to the new water system for fire protection.
- 3. Within one year from September 1, 1986, all existing structures and any future structures shall be painted the same red color with white trim as is presently on the Crane Shed, located on lot 2 Block 2 of said plat.

4. Said land is being conveyed on the condition that within one year, said land and all improvements shall be maintained in good repair and attractive condition and no materials, refuse collection containers, supplies or equipment shall be stored in any area on said land except inside a closed building, or behind a visual barrier, as approved by Grantor. (It is understood that lumber is not required to be stored in a building.) Such areas shall be screened so that they effectively reduce visibility from the neighboring property or streets. Screening may be accomplished by dense planting.

The one year period mentioned above shall commence on the date Industrial Way fronting the lot described above has been improved.

Grantor also reserves the water line and easements for fire protection until such time as the existing system is abandoned.

The conditions set forth above shall be specifically enforced by a court of law.
