AMENDMENT TO AMENDED AND RESTATED BYLAWS OF MOUNTAIN HIGH HOA (formerly known as MOUNTAIN HIGH HOMEOWNERS ASSOCIATION)

This Amendment amends that certain Amended and Restated Bylaws of Mountain High HOA, formerly known as Mountain High Homeowners Association, recorded in the records of Deschutes County, Oregon, on November 15, 2007, as Document No. 2007-59798 (the "Bylaws").

AMENDMENTS

Article VI., Section 5 of the Bylaws shall be deleted in its entirety and replaced as follows:

"Section 5. Treasurer:

The treasurer shall monitor and supervise all funds of the Association. Furthermore, he or she shall perform all duties incident to the office of treasurer of the Association. The Board of Directors may, by resolution, adopt financial procedures which may include the designation of persons or entities to carry out specific treasurer duties. The treasurer will serve as the Board liaison to the finance committee and the office management company, and will report or cause to be reported the financial status of the Association at meetings of the Board of Directors and Annual Meetings of the owners."

Article X., Section 2 of the Bylaws shall be deleted in its entirety and replaced as follows:

"Section 2. Execution of Instruments:

All instruments of the Association including but not limited to, checks, notes, drafts, acceptances, deeds, leases, and contracts, shall be signed by such person or persons as may be designated by resolution of the Board of Directors, and in the absence of any such resolution applicable to any such instrument, then such instrument shall be signed by the President of the Association."

Except as necessary to give full effect to the amendments set forth above, the Bylaws shall remain unmodified and in full force and effect.
