AMENDMENTS TO THE
MOUNTAIN HIGH DECLARATION

The Mountain High Homeowners Association Board of Directors at the April 25, 1992 Annual Homeowners Meeting proposed the following restrictions to amend the Declaration of Covenants, Conditions and Restrictions. In excess of 75% of the membership voted by a special mail-in ballot, to adopt the two amendments.

Article VI, Section 4, (3) No Motor Homes, Campers, Trailers and Camping Equipment. No motor homes, campers, trailers, boats or other camping equipment shall be stored or used for overnight living accommodations at Mountain High except in a designated recreational vehicle parking area. Parking of any of these vehicles within Alpine Village shall be limited to a period of 24 hours and only for the purpose of cleaning, loading or unloading the vehicle.

Article VI, Section 4, (j) It is the intent of this Declaration that parking of vehicles outside the garages provided each home be kept to a minimum. The garages shall be maintained in a manner that allows parking within the garage for as many vehicles as are used by the occupant, up to the capacity of the three-car garage. Inoperable or infrequently used vehicles shall not be stored in the garage if that results in parking other vehicles outside.
