RESERVATIONS, RESTRICTIONS AND COVENANTS

NI-LAH-SHA VILLAGE, PHASE 1

A PLANNED COMMUNITY

WHEREAS, the "Declaration of Reservations, Restrictions and Covenants, Ni-Lah-Sha Village, Phase I, a Planned Community" (hereinafter referred to as "Declaration") was recorded on the 4th day of _________, 1992, in Volume 27, page 931, Records of Deschutes County, Oregon; and

WHEREAS, paragraph N provides for the amendment of the Declaration by vote or agreement of the owners representing 75% of the total votes in the planned community; and

WHEREAS, the undersigned being the owners of more than 75% of the total votes in the planned community desire to amend the Declaration as hereinafter set forth;

NOW, THEREFORE, the Declaration is hereby amended as follows:

1. The following is hereby added to paragraph M.:

"Each manufactured home shall be occupied by at least one person fifty-five (55) years or older, unless the occupant is (a) the surviving spouse of a deceased owner who was at least fifty-five (55) years old at the time of his or her death; (b) the

devisee or heir of a deceased owner who was at least fifty-five (55) years old at the time of his or her death; or (c) the divorced spouse of an owner age fifty-five (55) years or older, who has been awarded the manufactured home by judicial decree.

No person under the age of eighteen (18) years may occupy any manufactured home. No guest under the age of eighteen (18) years shall be permitted to stay with any owner overnight for more than a total of forty- five (45) nights in any calendar year.

It is the intent of Ni-Lah-Sha Village to provide housing for persons fifty-five (55) years of age and older, and in this respect, the Association shall adopt such policies and procedures as are necessary to comply with the Federal and State of Oregon laws relating to the provision of housing for persons fifty-five (55) years of age and older.

Except as amended herein, the Declaration shall remain in full force and effect.

IN WITNESS WHEREOF, the undersigned being the owners of more than 75% of the total votes in Ni-Lah-Sha Village, have executed this Amendment as of this 18th day of <u>December</u>, 1992.
