## THIRD AMENDMENT TO DECLARATION OF RESERVATIONS, RESTRICTIONS AND COVENANTS NI-LAH-SHA VILLAGE, PHASE I A PLANNED COMMUNITY

WHEREAS, the "Declaration of Reservations, Restrictions and Covenants, Ni-Lah-Sha Village, Phase I, a Planned Community" (hereinafter referred to as "Declaration") was recorded on the 4th day of June, 1992, in Volume 267, page 931, Records of Deschutes County, Oregon; and

WHEREAS, paragraph N provides for the amendment of the Declaration by vote or agreement of the owners representing 75% of the total votes in the planned community; and

WHEREAS, the undersigned being the owners of more than 75% of the total votes in the planned community desire to amend the Declaration as hereinafter set forth;

NOW THEREFORE, the Declaration is hereby amended as follows:

- 1. The association is granted a ten (10) foot wide easement along the South border of lots 20, 21, and 22 for the purpose of placing and maintaining a stone wall entry way.
- 2. The Declarant and/or the Association shall have the right to screen any utility boxes, and transformers which are within the utility easements, including placement of a sight obscuring hedge along the west side of lot 21, said screenings to

be subject to the approval of the architectural control committee and to be maintained by the owners of lots upon which they are placed.

3. Except as amended herein, the Declaration as previously amended shall remain in full force and effect.




