WHEREAS the above named owners desire to amend the protective covenants heretofore placed upon North Pilot Butte Addition to the City of Bend, Deschutes County, Oregon, which protective covenants were recorded in Vol. 131, at Page 174, of Deed Records, Deschutes County, Oregon,

NOW, THEREFORE, the above named owners hereby declare that the protective covenants heretofore recorded for the Subdivision of North Pilot Butte Addition to the City of Bend, Deschutes County, Oregon, be amended as follows:

That Paragraph 3 of such covenants be, and it hereby is, amended to provide that the side yard requirements for Lots Fifteen (15) and Sixteen (16) of Block One (1), shall have a width of not less than Ten (10) feet on the street side.
