Now therefore, the Protective Covenants, as amended by Amending Documents. are amended as set forth in below. These amendments shall be effective upon recording of this document with the Deschutes County Clerk's Office.

AMENDMENTS TO PROTECTIVE COVENANTS FOR **OAKTREE SUBDIVISION PHASE III**

Material being added to the Protective Covenants, as amended by Amending Documents, is highlighted in **bold face type.** Text being deleted is shown with a line through deleted text (deleted text).

Item 11 of the Protective Covenants, as amended by Amending Documents, is amended to read as follows:

11. LANDSCAPING [TIMING]

- a. All front yards shall be landscaped within six (6) months after the exterior of a residence is finished with no less than 40% of the front yard to be in grass, the rest to be natural or with bark chips in a professional looking manner, but in no event later than six (6) months after occupancy of the residence.
- b. All front yards shall include a yard light constructed of the same type of masonry approved for the home constructed on the lot. The light shall be placed near the road and shall match the style and location of the yard lights found in the existing development at the time of application for ACC approval.
- c. All front yards shall include walkway lights on one side of the walkway from the house to the street. The lights shall be approved by the ACC.
