The Cooperative may limit the amount of electric energy furnished for industrial purposes. The Applicant will pay the minimum basic charge as set by the Board of Directors.

 The Applicant will cause his premises to be wired in accordance with witing specifications approved by the Cooperative and in conformity with the law, National Electric Code, National Safety Code and any applicable

local ordinance.

 The Applicant, by paying a deposit (ee, assumes no personal liability or responsibility for any debts or liabilities of the Cooperative.

The Applicant will comply with and be bound by such rules and regulations as may be established by the Board
of Directors from time to time.

8. The Applicant acknowledges receipt of Cooperative hand out sheet entitled "Electric Service Requirements."

 In the event suit or action is commenced to enforce any provision of this agreement. The prevailing shall be entitled to reasonable attorney fees and costs. This amount shall be fixed and is not related to electrical energy consumption.

The acceptance of this application by the Cooperative will constitute an agreement between the Applicant and the Cooperative, and the contract for electric service shall continue in force for the contract for electric service was made available by the Cooperative to the Applicant, and thereafter until concelled by at least thirty (30) days written notice by either party to the other party.
