AMENDMENT TO DECLARATION  
AND SITE PLAN AND FLOOR PLANS  
OF  
POLE HOUSES I

THIS AMENDMENT is made and executed this 15<sup>th</sup> day of January, 1971, by SUNRIVER PROPERTIES, INC., an Oregon corporation, hereinafter called "Developer," pursuant to the provisions of the Unit Ownership Act of Oregon,

W I T N E S S E T H:

On September 2, 1970, Developer executed a declaration submitting Pole Houses I to the provisions of the Oregon Unit Ownership Law. That declaration was recorded on September 3, 1970, in Volume 171, at page 971, Deed Records of Deschutes County, Oregon. Appendix A to the declaration lists the carport spaces, if any, which pertain to each unit. Contemporaneously with filing the declaration, the Developer filed a Site Plan and Floor Plans of Pole Houses I. Said Plan shows the location of each carport space.

The Appendix to the declaration and the site plan failed to show carport space No. 10, which carport space relates to Unit 10.

NOW, THEREFORE, Developer submits herewith an amended Site Plan and Floor Plans of Pole Houses I, which amended plan depicts the correct location of carport space No. 10. In addition, Developer submits a corrected Appendix A to Declaration Submitting Pole Houses I to Oregon Unit Ownership Law, which appendix lists carport space No. 10 as pertaining to Unit 10.

IN WITNESS WHEREOF, SUNRIVER PROPERTIES, INC. has caused this amendment to be executed this 15<sup>th</sup> day of January, 1971.

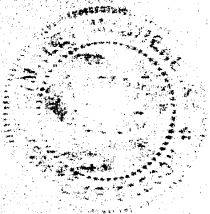

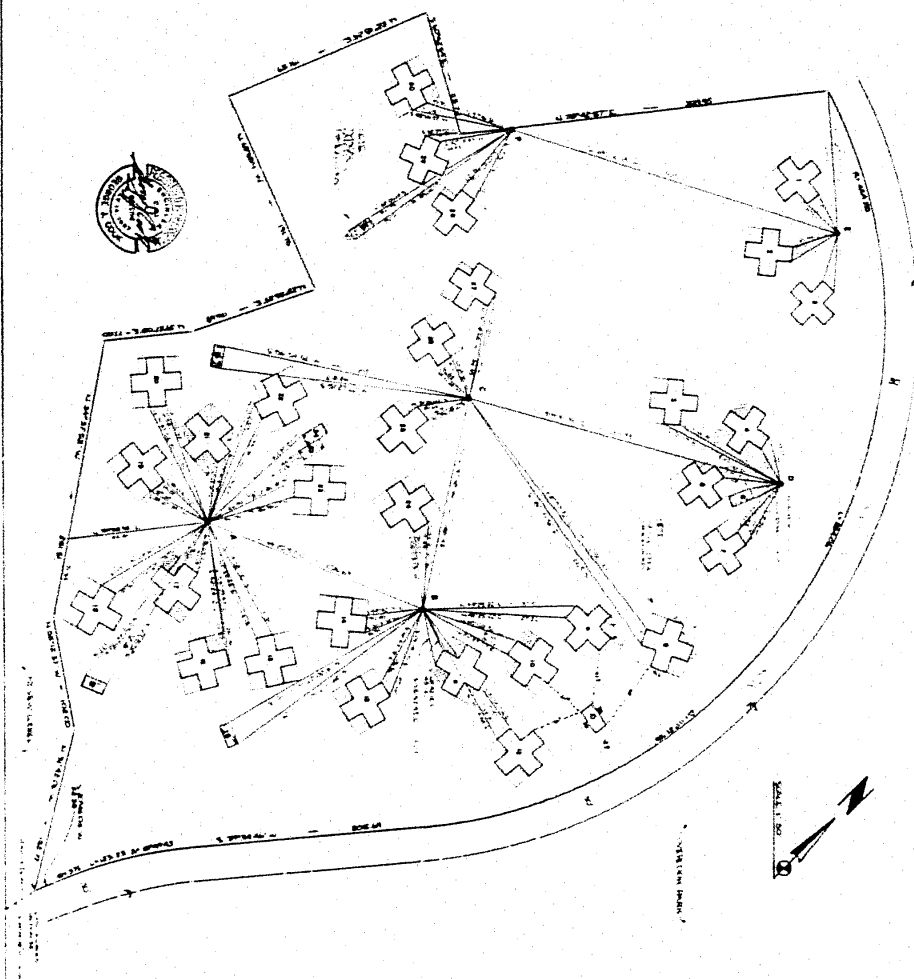
