AMENDMENT TO DECLARATION
OF

THIS AMENDMENT is made by the Association of Unit Owners of Polehouses I, pursuant to the provisions of the Unit Ownership Act of Oregon.

WITNESSETH:

On September 2, 1970, Developer executed a Declaration submitting Polehouses I to the provisions of the Oregon Unit Ownership Law. That Declaration was recorded on September 2, 1970, in Volume 171, at page 971, Deed Records of Deschutes County, Oregon. A subsequent Amendment to Declaration was filed on January 15, 1981.

The Association has received a grant of additional property from Sunriver Properties Oregon, Ltd. and wishes to add said property to that recorded in the original Declaration and record said property as a limited common element under Oregon Unit Ownership Law.

NOW THEREFORE, the Association submits an Amendment to the original property description, adding the following property as a limited common element under the Oregon Unit Ownership Law:


"A tract of land being a portion of Lot Two (2), Block Eleven (11), OVERLOOK PARK III, Deschutes County, Oregon, more particularly described as follows: Beginning at the Northeast corner of said Lot 2; thence South 25 37'06" West along the Easterly line of said Lot 2 a distance of 96.62 feet; thence South 39 07'45" West continuing along said Easterly line a distance of 32.00 feet; thence North 23 08'31" East a distance of 126.74 feet to the Northerly line of said Lot 2; thence South 69 17'34" East along said Northerly line a distance of 13.00 feet to the point of beginning".

IN WITNESS WHEREOF, the Association of Unit Owners of Polehouses I has caused this Amendment to be executed this 21st day of July, 1983.



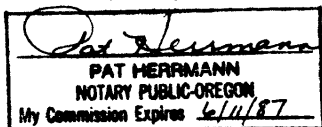
