1. Article 3, Paragraph 6 J. change % to 50 % or more.
2. Article 3, Paragraph 9, Add: All Board of Directors Meetings shall be open to all unit owners.
3. Article 7, Paragraph 1, Add: Sub-paragraph (e) to read: Explanation of a, b, c, and d of this paragraph is explained in detail in the declaration submitting Polehouse I to the O.U.O. law.
4. Article 7, Paragraph 4. Change % to 50 % or more.
5. Article 7, Paragraph 5. (b), Change % to 50 % or more.
6. Article 8, Paragraph 2. Change % to: a majority-more than 50 %.

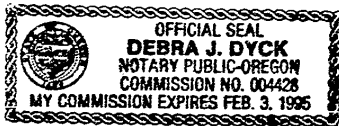
