

AMENDMENT TO DECLARATION ESTABLISHING RANCH CABINS
AND ANNEXING RANCH CABINS TO MOUNTAIN VILLAGE (AND
SUPPLEMENTAL DECLARATIONS AMENDING DECLARATION ES-
TABLISHING RANCH CABINS AND ANNEXING RANCH CABINS

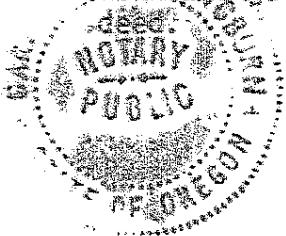
