"6. Dwellings may be constructed on lots or fraction of lots in Ranch Way Acres as shown on the plat, but no dwelling shall be constructed on a lot or fraction of a lot in Ranch Way Acres with square feet of less than 7500 square feet.

On all lots or fraction of lots in Ranch Way Acres, no residences shall be constructed with less than 1250 square feet living area, exclusive of garages, porches and outbuildings.
