

BUILDING AND USE RESTRICTIONS FOR RIMROCK WEST DESCHUTES COUNTY, OREGON

SO MUCH OF THE BUILDING AND USE RESTRICTIONS FOR RIMROCK WEST, DESCHUTES COUNTY, OREGON, recorded November 8, 1972 in Volume 189, Page 865-871 inclusive and as amended is further amended as follows:

l a. The description as appears for Parcel 2 in Section A Preamble is deleted and the following is substituted therefore:

"Parcel 2: That portion of the Southwest Quarter of the Southwest Quarter (SW1/4SW1/4), Section 17, Township 17 South, Range 12 East WM lying south and west of the Deschutes River.

b. The description as appears for Parcel 3 in Section A Preamble is deleted and the following is substituted therefore:

The Southeast Quarter of the Southwest Quarter (SE1/4SW1/4) Section 17, Township 17 South, Range 12, East of the Willamette Meridian, lying south and west of the Deschutes River.

- 2. Paragraph C(1)(a) is deleted in its entirety and the following substituted therefore: "No lot shall be used except for residential purposes. No building other than a detached single family dwelling and a private garage compatible with the terrain of

the lot and the surrounding environment shall be erected or placed or permitted to remain on any lot."

3 a. The second item of paragraph C(2) is deleted in its entirety and the following substituted therefore:

"The configuration of each home will be compatible with its site and the adjacent lots as determined by the Architectural Committee.

- The Fifth item of paragraph C(2) is deleted in its entirety and the following substituted: "The use of semi-transparent, wood stains in lieu of paints will be required. Bright paint on exteriors other than in the trim and in accent panels will be discouraged and will be approved only in unusual locations.
- Previously recorded amendment in Book 253, Page 198 Deed Records recorded June 29, 1977 is corrected to apply to paragraph C(14) and paragraph C(14) further amended to delete the words: "No individual sewage disposal system shall be permitted on any lot." and the following is substituted therefore: "No individual sewage system shall be permitted on any lot unless approved by the Deschutes County Sanitarian or his successor authority." Dated this 22nd day of May, 1980, at Bend, Oregon.
