WHEREAS, the Declarant desires to correct certain recording information set forth in said Supplemental Declaration,

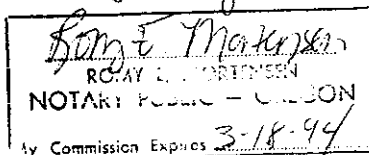
NOW, THEREFORE, the Supplemental Declaration for River Ridge One Condominiums of Mt. Bachelor Village, Stage B, is corrected as follows:
