

**SUPPLEMENTAL DECLARATION TO ROCK RIDGE

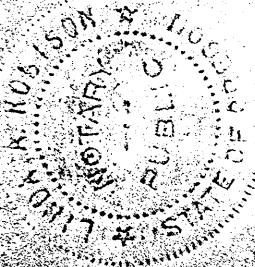
