## SEWER EASEMENT DEED

BEND PARTNERS, L. P. a California limited partnership, Grantors, conveys and warrants to the CITY OF BEND, an Oregon municipal corporation, Grantee, the following sewer facilities easement free of encumbrances except as specifically set forth herein:

## SEE EXHIBIT "A"

This easement is granted on the following terms and conditions:

- 1. The easement shall be a permanent, perpetual and exclusive right to construct, install, maintain and operate a sewer line and all related facilities on the surface and within the subsurface of the easement. City shall have the right to immediate possession of the property described in this easement.
- 2. The City of Bend shall hold Grantor harmless from any liability caused by City's work within the easement or the operation and maintenance of the sewer line.
- 3. Grantor shall not erect any structures on the easement, but may use the surface of the easement provided such use does not interfere with City's construction, installation, operation and maintenance of its sewer system.
- 4. Grantor also grants to the City of Bend a temporary construction easement of 10.00 feet in width along each side of the permanent easement for the purpose of giving a work area during the construction of the sewer. Upon completion of the sewer construction and acceptance for use, this construction easement shall be terminated.
- 5. Grantor warrants and represents that the property subject to this easement is free and clear of all liens and encumbrances and that Grantor has the right to grant this sewer easement.
- 6. There is no consideration for this easement.
