

BROOKS RESOURCES CORPORATION conveys to the CITY OF BEND, a political subdivision of the State of Oregon, a non-exclusive easement for water line purposes over and across a strip of land twenty (20) feet in width located in the Southeast quarter of the Southwest quarter (SE $\frac{1}{4}$ SW $\frac{1}{4}$) and the Southwest quarter of the Southeast quarter (SW $\frac{1}{4}$ SE $\frac{1}{4}$) of Section 6 and the West half of the Northwest quarter of the Northeast quarter (W $\frac{1}{2}$ NW $\frac{1}{4}$ NE $\frac{1}{4}$) and the Southeast quarter of the Northeast quarter of the Northeast quarter (SE $\frac{1}{4}$ NE $\frac{1}{4}$ NE $\frac{1}{4}$) of Section 7, Township Eighteen (18) South, Range Twelve (12) East of the Willamette Meridian, City of Bend, Deschutes County, Oregon, whose centerline is described as follows:

Beginning at a point located on the centerline of an existing water line easement, said point being located North 38° 14' 33" West, 235.86 feet from the North Quarter corner of said Section 7; thence South 84° 37' 38" East 168.74 feet; thence North 88° 54' 22" East 81.65 feet; thence South 87° 48' 53" East 44.60 feet; thence South 79° 18' 33" East 46.57 feet; thence South 68° 48' 54" East 50.57 feet; thence South 48° 27' 01" East 140.53 feet; thence South 10° 16' 08" East 52.91 feet; thence South 07° 44' 03" West 46.25 feet; thence South 15° 46' 40" West 186.35 feet; thence South 22° 35' 10" West 93.07 feet; thence South 17° 56' 09" West 47.23 feet; thence South 09° 53' 43" West 95.12 feet; thence South 05° 24' 38" East 27.38 feet; thence South 18° 50' 49" East 144.36 feet; thence South 09° 13' 23" East 46.87 feet; thence South 06° 46' 10" West 42.50 feet; thence South 24° 22' 58" West 43.91 feet; thence South 40° 29' 52" West 380.56 feet; thence South 60° 46' 55" West 55.37 feet; thence South 74° 02' 21" West 203.81 feet; thence North 62° 12' 16" West 19.89 feet; thence South 73° 01' 02" West 19.03 feet to the centerline of the existing water line serving the plat of Ski House II Condominiums and the terminus of this description.

including the right to use this land for the construction, installation, operation and maintenance of a pipeline for the transmission of water and all things necessary to that purpose.

There is no consideration for the granting of this easement. This easement is being recorded to correct the legal description in the water line easement recorded in Book 261, Page 609, Deed Records.
