RECITALS

NOW THEREFORE,

The First Restated Declaration of Arrowood Summit At Skyliner Summit At Broken Top is amended as follows:

Section 10.4 (b) is revoked and amended to read as follows:

"Allocation of Assessments. Except as provided below, the total amount in the budget will be charged equitably, based upon historical and projected costs, between the one and two story lots as annual assessments."
