AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR REPLAT OF SNOW CREEK RANCH

WHEREAS, a Declaration of Covenants, Conditions and Restrictions for Replat of Snow Creek Ranch dated December 21, 1995, was originally recorded in the Deschutes County Real Property Records at Book 394, page 1855, to bind the real property described on the attached Exhibit "A" (the "Declaration" and "Real Property." respectively);

WHEREAS, the undersigned owners of the Real Property wish to amend the Declaration as provided herein pursuant to their power to amend set forth in Section 4.2 of the Declaration;

NOW THEREFORE, the undersigned hereby agree as follows:

AGREEMENT

1. <u>Amendment.</u> The following Section 1.10 is bereby added to the Definitions of the Declaration:

"I 10 Permitted Agricultural Uses. Uses contemplated by the terms "permitted agricultural uses," "agricultural businesses," "home occupations," and/or "agricultural or livestock purposes" shall not include packaging, processing, manufacturing, remanufacturing, storage, or any other similar use for either 1) agricultural commodities or crops or products which have not been produced on an Owner's Lot or 2) livestock which have not been raised or regularly kept on an Owner's Lot."

- 2. <u>No Other Modifications</u>. Except as modified herein, the Declaration shall remain in full force and effect as originally recorded.
- Effectiveness. All owners of four of the seven lots set forth below must execute this
 agreement in order for it to be effective, after such execution the amendment shall be
 recorded in Deschutes County. Oregon.
