Recitals

THIS THIRD AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS, AND RESTRICTIONS FOR SUMMIT CREST (this "Third Amendment") is made and entered into this 5⁷¹⁴ day of FEBRUARY, 2010, by D. R. Horton, Inc. - Portland, a Delaware corporation (the "Declarant") and by Summit Crest Homeowners' Association, Inc., an Oregon non-profit corporation (the "Association").

WHEREAS, the Declarant caused that certain Declaration of Covenants, Conditions and Restrictions for Summit Crest to be recorded on February 23, 2007 (the "Declaration") as Document No. 2007-11054 in the records of Deschutes County, Oregon; and the First Amendment to the Declaration of Covenants, Conditions and Restrictions for Summit Crest to be recorded on September 24, 2007 as Document No. 2007-51643 in the records of Deschutes County, Oregon; and the Second Amendment to the Declaration of Covenants, Conditions and Restrictions for Summit Crest to be recorded on April 11, 2008 as Document No. 2008-16066 in the records of Deschutes County, Oregon.

WHEREAS, pursuant to Section 11.6 of the Declaration and ORS 94.590, the Declaration may be amended at any time by an instrument approved by at least 75% of the total vote of each class of members eligible to vote, and whereas Declarant desires to amend the Declaration as provided herein.

- 5. The last sentence of Section 11.9 is amended to read as follows: "Prior to the Turnover Meeting, no Declarant amendment <u>pursuant to this Section 11.9</u> shall require notice to or approval by any Class A member."
- 6. Except as expressly amended hereby, the Declaration remains in full force and effect.
